In our opinion, proper accounting records have been kept and the financial statements, which are in agreement therewith, present fairly in all material respects the state of the company's affairs as at December 31, 2001 and of its net profit, changes in equity and cash flows for the year then ended and have been prepared in accordance with accounting standards generally accepted in Jamaica and comply with the provisions of the Jamaican Companies Act.
