## Carib Cement: Increase in Cement Prices

- Carib Cement has announced an adjustment to its ex-factory prices effective July 1, 2005. This adjustment is well in keeping with the Company's commitment to the people of Jamaica to keep the price of cement at the December 2003 level in US dollars. The average increase in the ex-factory price of cement will be 5.3%. The Company has had to make the adjustments due to the significant increases in the cost of oil, which has influenced increases in excess of 20% in the cost of electricity, spare parts and transportation. The last adjustment to prices was two years ago in July 2003 when prices were rolled back to pre-February 2003 prices.

## C & W: Appointment

- Ms. Jacqueline Holding will demit office as CEO of Cable & Wireless with effect from June 30, 2005. Mr. Rodney Davis will assume the position effective July 1, 2005. Mr. Rodney is returning to Jamaica from C&W (Barbados) where he has been Chief Financial Officer for the past year.
