Ja. Broilers Gp. - Acquisition

- The Board of Directors of the Company at a meeting held on July 24, 2006 approved the investment in the construction and the operation of an Ethanol Production Facility. It is expected that this Facility will be completed by May of 2007, and will have an Annual Ethanol Production capacity of 60 million gallons. The Company anticipates that the initial outlay for this project will be approximately US\$17M, and that same will be financed through a combination of debt and equity resources.

JLA - Dividend

- At a meeting held on July 25, 2006, the Board of Directors approved a semi-annual interim dividend of 4% on The Cumulative Participating Preference Shares outstanding as of record date August 17, 2006. The payment date is September 15, 2006.

Montego Freeport - Resignation

Pegasus - Dividend Consideration and Resignation

- The next Directors Meeting of Pegasus Hotels of Jamaica Limited is to be held on September 25, 2006, of which the recommendation of a dividend payment will be considered.
- Effective July 23, 2006, Dr. The Hon. Vincent Lawrence resigned as a Director of the Company.

GraceKennedy - Resignation and Appointments
