## Capital & Credit Merchant Bank: Resignation

#### Desnoes & Geddes: Dividend Consideration

#### Courts Jamaica Ltd: Take-over Bid

On Monday November 20, 2006, the Board of COURTS (Jamaica) Limited (Courts), received an offer from Cobalt Holding Co. Limited (Cobalt) to purchase 100% of all the issued ordinary stock units of J\$0.50 in Courts at a price of J\$4.25 per stock unit ('the Offer'). The Board is carefully considering the contents of the Take-over Bid Circular issued by Cobalt and the advice given to it by a special sub-committee of the Board appointed to consider the Offer and will make a recommendation in the Directors' Circular to its stockholders whether the offer should be accepted or rejected. The offer will open for acceptance at 2:30 p.m. on Tuesday, November 21, 2006 and close at 4:00 p.m. on Monday, December 18, 2006.
