Hoogesteger will continue to operate as a separate business unit, drawing on some management support and expertise from JP's Serious Food Company subsidiary and from the JP corporate offices in Kingston.

This acquisition of Hoogesteger further reflects the Group's renewed focus on its core juice business. It is a first step in achieving a significant presence on the European continent in line with our strategy of establishing the Group as the leading premium juice and smoothie business in Europe.

Hoogesteger employs 130 persons in the production of fresh juice and smoothies and has annual revenues of approximately 32 million euros. The Hoogesteger acquisition is valued at 9.2 million euros.
