PanCaribbean - Appointment

- Pan Caribbean Financial Services Limited has advised that the Board of Directors of PanCaribbeanBank Limited appointed Mr. Philip Armstrong as the Managing Director of PanCaribbeanBank Limited effective 1 March 2010.

GHL - Publication of Year End Results

GraceKennedy - To Delist from BSE & ECSE

- GraceKennedy Limited (GK) has advised that a decision was taken to delist its stock from the Barbados Stock Exchange (BSE) and Eastern Caribbean Securities Exchange (ECSE) as of the close of business on June 30, 2010 (the effective Date). The decision to delist was taken primarily due to the low levels of trading in GK's stock on both these exchanges which do not justify the costs associated with maintaining the listings. The company will however continue to maintain the listings on the Jamaica and Trinidad & Tobago stock exchanges. GK values the support and interest of its stakeholders in Barbados and the Eastern Caribbean and the delisting on these stock exchanges will not prevent its stockholders in these territories from continuing to maintain their investment in GK through either:
 - (i) the withdrawal of their stockholdings from the relevant central securities depository in Barbados or the Eastern Caribbean and request for a physical stock certificate in their own name or;
 - (ii) the transfer of their stockholdings from the Barbados Central Securities Depository or the Eastern Caribbean Securities Depository as the case may be to the Jamaica Central Securities Depository or the Trinidad and Tobago Central Securities Depository.

- Berger Paints Jamaica Limited has advised that after a review of the terms and conditions of the Jamaica Debt Exchange Programme with its Pension Fund Managers, it has been determined that the company's participation will not have a material effect on the company's financial position.
