DG - Trading in Shares

Desnoes & Geddes Limited (DG) has advised that a senior manager purchased 62,616 DG shares on October 8, 2013.

JMMB - Acquisition

Jamaica Money Market Brokers Limited (JMMB) has advised that JMMB through Jamaica Money Market Brokers (Trinidad and Tobago) Limited (JMMB's Trinidadian holding company) has obtained 100% ownership of Intercommercial Bank Ltd. and Intercommercial Trust & Merchant Bank Ltd. (IBL Group), having concluded the transaction to acquire the remaining 50% shareholding in those entities on October 3, 2013; making it JMMB's very first commercial bank.

CCC - Price Increase

Caribbean Cement Company Limited (CCC) has advised that there will be an average increase of 2.7% on all CCC products effective October 22, 2013.

TCL - Notice to Shareholders & Employees

Trinidad Cement Limited (TCL) has advised that, as previously reported, on Friday 12th July, 2013, the Honourable Mr. Justice Harris granted an injunction restraining the holding of TCL's Annual Meeting scheduled for 4:30 p.m. on that same day. TCL filed a Notice of Appeal challenging the granting of the injunction. The Court of Appeal Hearing had been fixed for Monday 30th September, 2013 but was rescheduled by the Court to Wednesday 9th October, 2013. The attorneys for the proposing shareholders applied for a further postponement of the hearing, due to the unavailability of their Senior Counsel. The Appeal has therefore been further rescheduled to Wednesday 13th November at 9:00 a.m.
