What is Online Trading?

Online trading allows you to use a portal to buy and sell securities such as stocks, options, bonds and mutual funds via an online trading platform. It offers convenience, allows you to avoid lengthy waiting periods for placing an order and helps investors manage their transactions with the click of a mouse. The JSE's online trading platform will be offering investors the opportunity to trade securities listed on the Board of the JSE.

Features of Online Trading

<u>Convenience</u>

You don't have to wait until business hours to place an order through your broker. You can place an order at your convenience anytime using the online trading platform. However, your transaction will be executed on **business days** (Monday -Friday) between the hours of 9:30 a.m. - 1:00 p.m. Activities include:

The Online Platform

The online trading platform is user friendly. It provides the ability to trade securities, view market data, monitor orders, account balance and more, all from your desktops and smart devices.

Registration

Registration is simple and easy for online trading access, once you follow the instructions given. Once registered you may add or request a Broker & JCSD account through a broker.

<u> JCSD Accounts</u>

Do you have a JCSD account? If so, you can add these to your online trading profile. If not, you can request an account after the registration process is complete. You are able to add several JCSD accounts for online trading.

Order Execution
