2. Paragraph 44 of the Offer Circular is amended to read as follows:

"Once it has received acceptances of 90% or more **in value and 75% or more in number** of the minority-held stock in CWJ as a result of this Offer, it is the intention of CWJ to exercise its rights under the Companies Act of Jamaica to compulsorily acquire the shares of all other shareholders, including those who have expressly dissented or have failed to respond to this Offer." 3. The following paragraph be added to the Offer Circular as paragraph (q) of Appendix 1 to the Offer Circular:

"An application has been filed by a shareholder of Cable & Wireless Jamaica Limited ("CWJ") seeking the leave of the Supreme Court of Jamaica to bring a derivative action in the state of Florida, United States of America, in the name of and on behalf of CWJ against the directors and shadow directors of CWJ (which he claims includes Cable & Wireless Plc and Cable & Wireless Caribbean Limited) for breaches of fiduciary duty causing CWJ to suffer loss and damage. The Offeror is not a party to this litigation and CWJ has indicated that it intends to vigorously oppose the application when it comes on for hearing on the 19th day of April 2018."
