# Jamaica Stock Exchange June 2019 Regulatory Report

#### **Overview**

This is the Jamaica Stock Exchange's (JSE) June 2019 Monthly Regulatory Report. The report gives a synopsis of the following regulatory activities:

- 1. Member-dealers' reporting,
- 2. Listed companies' submissions,
- 3. Market surveillance and compliance activities,
- 4. Regulatory breaches and enforcement actions.

#### **Member-Dealers' Reporting**

In accordance with JSE Rule 209 (A) member-dealers were required to file Monthly Reports for the period ended May 31, 2019 by July 1, 2019. For the reporting period, thirteen (13) Monthly Reports were due and of the thirteen (13), twelve (12) were submitted on time.

Based on JSE Rule 209 (B) member-dealers were required to file Quarterly Reports for the period ended May 31, 2019 by July 1, 2019. For the reporting period, no Quarterly Reports were due, hence no filings were made.

Under JSE Rule 209 (C) member-dealers with financial year ended March 31, 2019 were required to file their Audited Reports by June 30, 2019. For the reporting period, three (3) Audited Reports were due and submitted on time.

The aggregate compliance rate for member-dealers' filing of Monthly, Quarterly and Audited Reports for the month ended June 30, 2019 was 94%. For the 2018 comparative period, member-dealers' aggregate compliance rate was 100%. For the reporting period ended May 31, 2019, all member-dealers satisfied the JSE's Excess Net Free Capital (ENFC) requirement as prescribed by JSE Rule Appendix 12 – Member/Dealers' Report and Financial Information, which is represented in Table 1 below.

#### **Listed Companies' Submissions**

Listed Companies were required to file Unaudited Reports for the period ended April 30, 2019 by June 14, 2019. Listed Companies with year ended April 30, 2019 that selected the 60-days filing option were required to file Audited Financial Statements by June 29, 2019. Listed Companies with year ended March 31, 2019 that selected a 90-days filing option were also required to file their Audited Financial Statements by June 29, 2019. Additionally, Listed Companies with year ended February 2019 were required to file Annual Reports by June 28, 2019. The filing statistics are represented in Table 2 below:
