#### MIL - Trading in Shares

#### SRA - Suspension of Securities

Effective August 9, 2019, the Jamaica Stock Exchange (JSE) has suspended trading in Sweet River Abattoir and Supplies Company Limited (SRA) for breaches of the JSE's Junior Market Board Level requirements. The Company is being suspended for failing to have an independent non-executive on its Board as required by the rules of the JSE's Junior Market.

#### JBG - Appointments

Jamaica Broilers Group (JBG) has advised of the following changes to the Company's senior management:

- Dr. Claudette Cooke demits office as Group Vice President -Human Resource Development & Public Relations effective July 31, 2019. Dr. Cooke has been employed to the JBG for twentyseven (27) years and will continue to serve on the Board as a Non-Executive Director.
- Assistant Vice President Human Resource Development and Public Relations, Ms. Rochelle Cameron, tendered her resignation effective July 31, 2019.
- Mr. Lennox Channer, Group Vice President Accounting will have a new addition to his portfolio. As of August 1, 2019, he will function as Group Vice President - Accounting & Administration, with added responsibility for the Human Resource function.

## JMMBGL - Additional Public Share Offer

JMMB Group Limited (JMMBGL)has advised that on August 2, 2019, the Board of Directors, via a Round Robin Resolution, approved a proposal for the Company to seek, at its next Annual General Meeting, the approval of its ordinary shareholders to issue of up to 325,000,000 additional ordinary shares in the capital of the Company, ranking pari passu upon issue, in all respects with the existing ordinary shares of the Company. The terms and conditions of such issue of additional ordinary shares is to be determined by the directors.

### **KPREIT - Increase of Company's Share Capital**

Kingston Properties Limited (KPREIT) has advised that at a duly convened Extraordinary General Meeting of the shareholders of KPREIT, the Company passed a resolution to increase the authorised shares of the Company from 500,000,000 ordinary shares to 1,000,000,000 ordinary shares.

KPREIT further advised that the increase in share capital is part of the Company's strategy to substantially increase its capital base over the next three years, which includes a renounceable rights issue in short order.
