Registration

Registration will be required in order to attend the AGM. Shareholders and non-shareholders are invited to use the below link to register for the AGM (it works best using Chrome):

Shareholders will require their JCS D Account Number in order to complete registration and to be able to vote on the resolutions raised at the AGM. Should you require assistance in obtaining this account number, you may do any of the following:

- (1) Contact your stock broker;
- (2) Review your dividend cheque or payment advice for “Account Number”; or
- (3) Contact the Registrar Services Unit of the Jamaica Central Securities Depository at (876) 967-3271 or via e-mail at jcsdrs@jamstockex.com.

Non-shareholders may also attend the meeting if they register as a guest using this same link.

Once registration and verification have been completed, an electronic link and a password will be sent to the same e-mail address that was used for registration. The link and password should not be shared with anyone. Each will work for only one user.

The deadline for registration is February 2, 2022.

During the AGM, questions may only be submitted through the Question and Answer functionality of the application and we will seek to address as many of them as possible that are relevant to the proceedings, in the designated “Audited Accounts” or “Question & Answer” segment of the meeting agenda.
- Voting by shareholders on all resolutions shown on the Notice of the AGM will be done by electronic means. Only those shareholders who have registered or their proxies will be able to vote on the resolutions. Voting may be done prior to the start of the AGM.
