



# Jamaica Stock Exchange's Monthly Regulatory Report October 2022

## Jamaica Stock Exchange October 2022 Regulatory Report

#### **Overview**

This is the Jamaica Stock Exchange's (JSE) October 2022 Monthly Regulatory Report. The report gives a synopsis of the following regulatory activities:

- 1. Member-dealers' reporting,
- 2. Listed companies' submissions,
- 3. Market surveillance and compliance activities,
- 4. Regulatory breaches and enforcement actions.

### **Member-Dealers' Reporting**

In accordance with JSE Rule 209 (A) member-dealers were required to file Monthly Returns for the period ended September 30, 2022, by October 31, 2022. For the reporting period, fifteen (15) Monthly Returns were due and of the fifteen (15), fourteen (14) were submitted on time.

In accordance with JSE Rule 209 (B) member-dealers were required to file Quarterly Returns for the period ended September 30, 2022, by October 31, 2022. For the reporting period, thirteen (13) Quarterly Returns were due and of the thirteen (13), twelve (12) were submitted on time.

Under JSE Rule 209 (C) member-dealers with financial year ended July 31, 2022, were required to file their Annual Returns by October 31, 2022. For the reporting period, no Annual Returns were due.

The aggregate compliance rate for member-dealers' filing of financial returns due for the month ended October 2022, was 93%. For the 2021 comparative reporting period, member-dealers' aggregate compliance rate was 92%. For the reporting period ended September 2022 all member-dealers, except one (1), satisfied the JSE's Excess Net Free Capital (ENFC) requirement as prescribed by JSE Rule Appendix 12 – Member/Dealers' Report and Financial Information, which is represented in Table 1 below.

Listed Companies were required to file Unaudited Reports for the period ended August 31, 2022, by October 15, 2022. Listed Companies with year ended June 30, 2022, were required to file Annual Reports by October 28, 2022. The filing statistics are represented in Table 2 below:
