# NOTICE OF EXTENSION OF OFFER

This is the Second Addendum to the Prospectus by 138 Student Living Jamaica Limited (138SL) published on September 1, 2023 in respect of an Additional Public Offering (APO) of up to 513,972,784 New Ordinary Shares (with an option to upsize by an additional 256,986,392 New Ordinary Shares).
