FESCO – Trading in Shares

Future Energy Source Company Limited (FESCO) has advised that a Director purchased a total of 270,000 FESCO shares on October 11, 2023.

However, the meeting will continue on October 27, 2023 so that deliberations will continue on the possibility of a renounceable rights issue and whether it should recommend a stock split to shareholders of the Company at the Board meeting.

ELMIC – Resignation

EquityLine Mortgage Investment Corporation (ELMIC) has advised that Brian Koscak has resigned as a Director of the Company effective October 20, 2023 due to personal reasons. Mr. Koscak served as an Independent Director from November 10, 2022 and transitioned to Director on August 15, 2023.

ICREATE – Delay in Submission of Annual Report

iCreate Limited (ICREATE) has advised that its annual report for the year ended December 31, 2022, will be published on or before October 27, 2023. ICREATE has further advised that the delay is due to the additional time required to present a comprehensive report to shareholders and various stakeholders on the corporate happenings of the Group in 2022 and also to provide insights into the future of the Company.
